

Husqvarna Canada Corporation's 2020 Fall Review Contest - Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **SPONSOR:** The sponsor of this Contest is Husqvarna Canada Corporation, located at 850 Matheson Blvd. W., Unit 1, Mississauga ON L5V 0B4, Canada (the "**Sponsor**" or "**Husqvarna**").
2. **ACCEPTANCE OF RULES:** By entering the **Husqvarna Canada Corporation's 2020 Fall Review Contest** (the "**Contest**"), you (the "**Entrant**") hereby accept and agree to these official rules (the "**Rules**") of the Contest. Any violation of the Rules may result in disqualification.
3. **ELIGIBILITY:** The Contest is open only to legal residents of Canada who are 18 years of age or older as of the date of entry (or have reached the age of majority in the province or territory of residence at time of entry). Husqvarna employees, officers, directors, agents and representatives, and each of their respective parent corporations, subsidiaries, affiliates, sales representatives, distributors, licensees, prize providers, contractors or agents (all of the foregoing together with Sponsor, collectively, "**Contest Entities**"), and their immediate family members (spouse, parent, child, sibling and their respective spouses) and those living in the same household of each (whether legally related or not), are ineligible to enter or win the Contest. All applicable federal, provincial and local laws and regulations apply. Void where prohibited by law.
4. **CONTEST PERIOD:** The Contest begins at 7:00:00 a.m. Eastern Time ("**ET**") on November 10th, 2020 and ends at 11:59:59 p.m. ET on January 2nd, 2021 (the "**Contest Entry Period**"). Potential Winners (defined below) will be selected from Entries properly submitted to the Contest.
5. **CONTEST ENTRY INSTRUCTIONS:** NO PURCHASE NECESSARY. Internet access and valid email account required. Online entry through the Website (as defined below) only; no other means of submission will be accepted.

There is one (1) method of entry for this Contest: To enter during the Contest Entry Period, go to <https://www.husqvarna.com/ca-en/critiquesweepstakes> ("Website") and sign up for the Contest by providing all of the required information ("Entry"). By submitting your Entry, you are indicating that you have read, understood and accepted these Official Rules.

Entries must be received within the Contest Entry Period to be eligible for the Contest. Entry must be submitted by the entrant him or herself. Entrant may only use one (1) email address. LIMIT: one (1) Entry per person during the Contest Entry Period. Multiple Entries received from any one (1) entrant beyond this limit will void all such additional Entries. Any Entrant found to be using multiple accounts to enter will be disqualified. Entries generated by a script, macro, or other automated means will be disqualified.

In case of a dispute over the identity of an entrant, the authorized account holder of the email account associated with the entry used to enter will be deemed to be the entrant. "Authorized account holder" is defined as the person who is assigned to an email address by an Internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address. The Potential Winner may be required to show proof of being the authorized account holder.

6. **SELECTION OF CONTEST WINNERS:** On or before Friday, January 15th, 2021 at 8:00 p.m. ET ("**Contest Draw Date**"), two (2) entrants will be selected by a random draw from all eligible Entries received during the Contest Entry Period (each a "**Potential Winner**"). The odds of being selected as a Potential Winner are dependent upon the total number of eligible Entries received by the Sponsor during the Contest Entry Period. One Prize per Potential Winner.
7. **PRIZE CLAIM CONDITIONS AND NOTIFICATION:** : Before being declared a winner, the Potential Winner shall be required to: (1) correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered during a pre-arranged telephone call; and (2) confirm compliance with the Official Rules. Upon verified completion of these activities, the Potential Winner will be declared a Winner ("**Winner**"). The Sponsor may, in its sole discretion, provide an alternate skill-testing question or vary the requirements to perform any skill-testing component of the Contest to accommodate and include the participation of entrants with physical or cognitive disabilities.

Sponsor will notify the Potential Winner by email within three (3) business days after the Contest Draw Date. Please check your email. By entering the Contest, you consent to Sponsor contacting you in this manner should you be selected to win a prize. The

notification will contain instructions about responding, and the Potential Winner must respond by email within three (3) business days. At the sole discretion of the Sponsor, disqualification, forfeiture of the prize, and the selection of an alternate winner (who will be subject to disqualification in the same manner) may result from a Potential Winner's failure to: (1) respond to notification within the timeframe noted above; (2) provide Sponsor with satisfactory proof of eligibility; (3) correctly answer the time-limited mathematical skill-testing question within the timeframe provided; (4) return the fully executed Release within the timeframe required; (5) validly claim the prize by January 30, 2021; or (5) comply with the Official Rules. The Sponsor is not responsible for the failure for any reason whatsoever of a Winner to receive notification if properly sent as described above or for the Sponsor to receive a Winner's response.

The Prize may not be assigned, substituted, redeemed or exchanged for cash. The Prize will not be replaced if lost or stolen. The Prize will be awarded, provided it is validly claimed by January 30, 2021, after which no alternate winners will be selected, nor unclaimed prizes awarded.

Except for the cost of the Prize, all expenses and costs, including but not limited to federal, state and local taxes, freight/shipping charges, and pre-delivery inspection, related to accepting and/or using the Prize, are the sole responsibility of the Winner. **ALL FEDERAL, PROVINCIAL AND LOCAL TAXES IMPOSED ON THE ACCEPTANCE OF A PRIZE ARE SOLELY THE RESPONSIBILITY OF THE WINNER.**

The personal information will be hosted on servers in the United States, and the personal information you provide may therefore also be subject

In the event of such cancellation, termination, modification or suspension, Sponsor will select a winner from all eligible, non-suspect entries received prior to such action.
16. **FOR RESIDENTS OF QUÉBEC:** Any litigation respecting the conduct or organization of a publicity Contest may be submitted to the *Régie des alcools, des courses et des jeux* for a ruling. Any litigation respecting the awarding of a prize may be submitted to the *Régie* only for the purpose of helping the parties reach a settlement.
